Conference The Taif Agreement 25 Years Later

22 - 24 October, 2014 Beirut, Phoenicia Hotel On October 22nd, 1989, the Document of National Accord (popularly dubbed as the "Taif Agreement") was declared. A few days later, on November 5th, the agreement was ratified by the Lebanese Parliament.

- What has become of this agreement, the provisions of which were grouped under four headings:
- General Principles and Reforms
- Spreading the Sovereignty of the Lebanese State over all the Lebanese Territories
- Liberating Lebanon from the Israeli Occupation
- Lebanese-Syrian Relations
- What has been the outcome of the agreement? What role does it play, a quarter of a century since its declaration?

For more accuracy, the question might better be reformulated as:

- What are the Lebanese, regional and international positions, avowed or actual, on this agreement:
- On its text and its implementation, on its legal and moral value;
- On continuing to observe its implemented provisions or working to implement what has not been implemented yet;
- On correcting its application, amending its provisions or supplementing them;
- On moving past this agreement to an alternative that would herald a possible fresh start;

For a clearer illumination of the practical purpose of the conference, the question might be put as follows:

- What is the Lebanese national position on the agreement in terms of the aspirations for Lebanon, from the angle of the Lebanese state and of its people?
- Moreover, what are the positions of the international community, first and foremost, and the positions of countries having a stake in the affairs of Lebanon, whether as a matter of concern or influence: What is their situation in reality, and what should their position be, in the interest of Lebanon and the law?

For this purpose, the Civil Center for National Initiative and the Friedrich-Ebert-Stiftung (FES) Foundation, are organizing this conference, with the following guiding principles:

- To ensure the participation of Lebanese and non-Lebanese stakeholders in the conference, given the national and international importance of its theme, regardless of their support or their opposition, in part or in full, to the agreement;
- The sole rationale for participation, indeed for organizing the conference, is to strive for a rational dialogue, from the lens of the Lebanese national interest or lawful particular interests, and from the perspective of the principles of international law; Lebanon's socio-political structure and international cultural, economic and political relations, as well as our targeted purpose, were taken into account in inviting the speakers to the conference. Over the course of two days, Lebanese stakeholders from the political, religious and civil spheres will be meeting with representatives from international organizations, as well as figures who participated in the preparation process, in the negotiations and the formulation the agreement, and researchers who have studied the agreement, its implementation and possible corrections
